

# Nick Jr. Terms

## Terms & Conditions – Petits Filous Prize Draw (the “Prize Draw”)

1. This promotion is open to UK residents aged eighteen (18) years or over with children aged sixteen (16) years or under. Proof of age may be required. 5. Upon submitting an Entry, you will be asked to provide your name, address (including your postcode), your contact telephone number and email address.
6. There will be one (1) Winner (“**Winner**”) and four (4) Runners-up (“**Runners-up**”). \*\*\* Children must be aged sixteen (16) years or under.

(the “**Runners-up Prize**”)
